LATEST REVIEW OF “VISITING WITH CARE – A PATHWAY”

As scheduled, the Public Health Expert Reference Group within the Public Health Agency has recently completed its latest formal review of surveillance information as required in “**Visiting With Care – A Pathway**”.

Review Outcome

Based on the analysis of the available surveillance information (see **Appendix 1** below) I can confirm that the Department has accepted the recommendation for visiting in Care Homes to continue to be facilitated within the parameters set out in the third full stage of the Pathway – “**Further Easing**”.


As was flagged in last month’s update notification letter, we have worked with PHA colleagues to develop a useful information leaflet which should be shared with residents and their families. The leaflet, which conveys the outcome of the latest review in an accessible way, is attached at **Appendix 2** below. We intend to provide an updated version of this following every

review cycle, which will include details of the review outcome alongside other key messages around the safe facilitation of visiting as we move forward together.

Finally, to reflect a recent update to the PHA advice for visiting arrangements in care homes experiencing an outbreak of COVID-19, the Outbreak algorithm has been updated to reflect the recent changes in testing and is attached for information at **Appendix 3**.

Thank you for your ongoing efforts to provide safe effective care for our care home residents.

Summary of Public Health Expert Reference Group Findings:

- At the time of the review, one to two new care home COVID-19 outbreaks have been reported each day, on average.
- The Office for National Statistics Coronavirus COVID-19 Infection Survey has become an increasingly important indicator of the prevalence of COVID-19 as it is unaffected by changes in population testing policy and practice. This shows that following the period of very high prevalence since the beginning of 2022 the percentage of people in Northern Ireland who would have tested positive which is a proxy measure of prevalence had fallen to one in 30 people during the period of 10 - 16 April 2022.

- The total number of cases has fallen to a seven day average of 565 each day.
- Cases aged 70-79 years and 80+ years show a slow reduction over the last week.
- Reduced testing will increasingly affect the reliability of case counts and rates.
- The daily number of people admitted to hospital as an emergency with community acquired COVID-19 has reduced over the last four weeks.
- The number of care home residents who died and had COVID-19 mentioned on their death certificates fell in recent weeks with two such deaths reported in the week ending Friday 15 April 2022.
- The COVID-19 vaccine coverage in care home residents and staff is illustrated Figure 7 A and B. Most cases of SARS-CoV-2 infection in Northern Ireland are of the Omicron lineage. This is very easily transmitted, but it carries a lower risk of hospital admission or death for cases than previous variants. We have reported 16 cases of a new variant, XE which contains parts of the BA.1 and BA.2 Omicron sub-lineages. This variant has spread more quickly in England than BA.2, but there is limited information available at this time about any change in severity.

Testing and Transition

A change in testing took effect on 25 April 2022 with further changes planned towards the end of June 2022. This signals a change in approach and management of COVID-19 in care homes. The overall assessment and pathway recommendation takes account of those changes.
